The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for HOUSTON COUNTY ESD2 from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that HOUSTON COUNTY ESD2 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that HOUSTON COUNTY ESD2 is proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 10, 2024 AT 6:00 PM AT Houston County Emergency Service Bldg. 600 Bradshaw St. Crockett, Texas 75835.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, HOUSTON COUNTY ESD2 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of HOUSTON COUNTY ESD2 at their offices or by attending the public meeting mentioned above.
